SUPERVISION AND CONDUCT

Students must be supervised at all times by a teacher or adult. Accompanying staff are responsible for the supervision and behaviour of students. MPavilion requests the following appropriate ratios of supervision:

- Minimum one teacher/adult for every fifteen students in F-Grade 1
- Minimum one teacher/adult for every twenty students in Grade 2 or above
- Minimum one teacher/adult for every twenty-five students in tertiary education

Students and teachers must comply with the instructions of MPavilion staff in relation to behaviour while present at the MPavilion. Please ensure that students understand that the MPavilion is a shared public space and that the needs of other visitors must be respected at all times.

Students must respect the MPavilion and its furniture. Students are not to climb on or otherwise inappropriately physically engage with the pavilion structure, and furniture should be handled with care.

Teachers should advise students that food and drink cannot be consumed during an education session, however water bottles are permitted.
